**THE HEALTH PRACTICE (AMENDMENT) REGULATIONS, 2017**

In exercise of the powers conferred by sections 28 and 42 of the Health Practice Law (2013 Revision), the Cabinet makes the following Regulations -

1. These Regulations may be cited as the Health Practice (Amendment) Regulations, 2017. Citation
  
2. The Health Practice Regulations (2013 Revision), in these Regulations referred to as the “principal Regulations”, are amended in regulation 4 as follows-
  - (a) in subregulation (1), by repealing paragraph (c) and substituting the following paragraph -  
“(c) an original or certified letter of good standing from a current board of registration issued no earlier than three months prior to the submission of the application;” and
  - (b) by repealing subregulation (10) and substituting the following subregulation -  
“(10)Where the applicant is a non-Caymanian health practitioner, the applicant shall provide written evidence at the date of application -
    - (a) that the applicant is or will be affiliated with one of the registered health care facilities in the Islands; or
    - (b) that the applicant is or will be employed by an educational institution, a medical school, a nursing school, a home health care company, or a home health care agency, in the Islands.”.Amendment of regulation 4 of the Health Practice Regulations (2013 Revision) - documentary and other evidence which is to accompany applications for registration
  
3. The principal Regulations are amended in Schedule 1 as follows - Amendment of Schedule 1 - forms
  - (a) in Form A, item 12 and Form D, item 9. a., by deleting the words “Overseas List ” wherever they appear; and

- (b) in Forms C and CA, by deleting the words “Lyria A. Lawson-Josephs RN, BSN, MSc.” wherever they appear.

Amendment of Schedule  
2 - fees

4. The principal Regulations are amended in Schedule 2 as follows -

- (a) by deleting item 8 and substituting the following item -  
“8. Fee for express processing \$500”;  
of application (to be processed  
within 7 business days after the  
application is reviewed and  
accepted by the Registrar)
- (b) by deleting item 9 and substituting the following item -  
“9. Fee for urgent processing of \$600”;  
application (to be processed  
within 3 business days after the  
application is reviewed and  
accepted by the Registrar)
- (c) by deleting item 10 and substituting the following item -  
“10. Fee for emergency \$750”; and  
processing of application (to be  
processed within 24 hours after  
the application is reviewed and  
accepted by the Registrar)
- (d) by inserting after item 10, the following item -  
“11. Fee to replace Practising \$100”.
